EFFECTS OF MASCARA IN THE ENVIRONMENT

RAW MATERIALS GATHERED FOR MASCARA ARE MOSTLY FROM PETROLEUM, HIGHLY UNSUSTAINABLE BECAUSE IT IS A NON-RENEWABLE RESOURCE, IT HAS PLAYED A ROLE IN OIL SPILLS, AND HAS DAMAGED NATURAL HABITATS, AND HAS BEEN A FACTOR IN CLIMATE CHANGE

MANUFACTURING STAGE-FUMES FROM THE MASCARA MIXTURE RELEASED INTO THE AIR SINCE THERE IS NO LID TO COVER THE MIXTURE PACKAGING- MOST MASCARA PRODUCTS ARE PACKAGED IN PLASTIC, WHICH IS NOT BIODEGRADABLE. THIS PACKAGING TYPICALLY GETS TOSSED INTO A LANDFILL, WHERE IT WILL NOT BE ABLE TO BREAK DOWN FOR HUNDREDS OF YEARS.

DISTRIBUTION- ONCE THE MASCARA IS PACKAGED, THE PRODUCT IS SHIPPED BY PLANES, RAILROADS AND TRUCKS TO VARIOUS STORES, WAREHOUSES, AND OTHER LOCATIONS (THESE TRANSPORTATIONS REQUIRE FOSSIL FUELS WHICH HAVE A NEGATIVE IMPACT ON THE ENVIRONMENT)

USAGE AND DISPOSAL- MASCARA TYPICALLY LASTS FOR ABOUT 3-6 MONTHS DEPENDING ON HOW MUCH YOU USE THE PRODUCT. MOST RECYCLING PROGRAMS DO NOT ACCEPT MASCARA TUBES DUE TO THE TYPE OF PLASTIC THAT THEY USE




Figure 1 Mascara can be manufactures using the anydrous method or the emulsion method (FDA)
